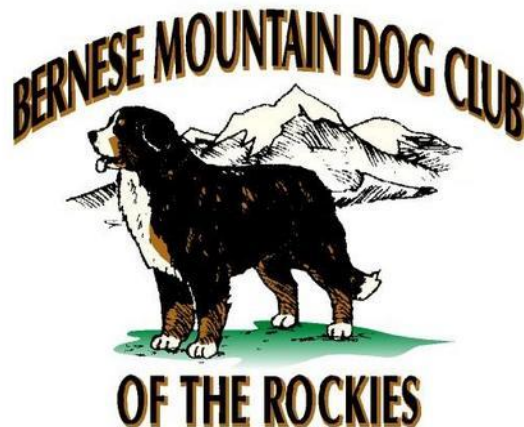

Mountain Dog Club of America Draft Test Purpose

The Bernese Mountain Dog Club of America Draft Tests are a series of exercises designed to develop and demonstrate the natural abilities of purebred Bernese Mountain Dogs in a working capacity involving hauling. The Bernese Mountain Dog has historically functioned as a draft dog in various capacities, and performance of these exercises is intended to demonstrate skills resulting from both inherent ability and training which are applicable to realistic work situations. Efficiency in accomplishment of tasks is essential. It is also desirable that the dog evidence willingness and enjoyment of his work in a combination of controlled teamwork with his handler and natural independence.

Class Entry Details

- There will be a limit of 24 entries per test.
- Entry fees \$ 35 for each single dog team and \$ 40 for a brace team
- A separate entry form must be filled out for each dog of a brace team and then submitted together. Even though two entry forms are required for each brace team, each brace team will be counted as one entry in the Draft Test entry limit.
- If more than 24 entries are received, they will be prioritized per the following order:
 1. Untitled BMDs
 2. Titled BMDs without Advanced/Master titles in the entered class
 3. Titled BMDs with Advanced/Master titles in the entered class
 4. Untitled other dogs
 5. Titled other dogs without Advanced/Master titles in the entered class
 6. Titled other dogs with Advanced/Master titles in the entered class
 - *Note: For brace teams, the dog with the lowest level title in the entered class determines the team's priority. If a brace has a BMD and a non-BMD, it is considered a "BMD team" for the above.*
 - *Note that "titled" means titled in the entered class.*
- Running Order: A separate random draw to determine the running order for each class for each test.
- Entrants must notify the Draft Test Secretary if a dog has earned a title in the entered class, including if the title is earned after the entry has been submitted.

Attention Exhibitors

- The following classes will be offered: Novice, Brace Novice, Open and Brace Open.
- Handlers must provide their own rigs, harnesses, and tie-downs or other means of securing a load on their particular draft rig.
- Handlers must bring their own weight. Weight will be verified via scale at the test site.
- Entered dogs must be 24 months old or older on the day of the Draft Test.
- Bitches in season are not permitted to compete. Refunds will be given for bitches in season or injured dogs with a veterinary certificate.
- The two dogs of a brace team need not be owned by the same person or by the handler.
- Un-entered dogs may be present but, like entered dogs that are not in the ring, must be leashed or crated and under control at all times.
- Please remember to be responsible dog owners and pick up after your dog(s).

Weight Certificates

Each Open or Brace Open entry shall include the DWC weight certificate or a certificate that includes the same information that is contained in the DWC WC (available on the BMDCA website) and be signed and dated within 60 days prior to each Draft Test date. The handler is solely responsible for having a valid Weight Certificate. An incorrect Weight Certificate may result in the loss of any qualifying runs.

Regulations

Draft Test Regulations: Entrants are responsible for obtaining the BMDCA Draft Test Regulations (revised as of January 2023) and being familiar with them.

Refreshments & Lunch

A "Build Your Own" Sandwich or Salad Bar will be available both days for \$10/person, for those who pre-pay by check mailed with entries or online at www.bmdcr.org/DraftTests.html. Please order lunches by 8:00 PM on October 4, 2023. If only ordering lunch for one day, please indicate which day. Water and soft drinks will be provided by the BMDCR.

Weather

Sunrise will be at 7:07 AM and sunset will be 6:22 PM. The average temperature on October 14th and 15th in Black Forest ranges from a high of 60° F to a low of 32° F. The basic control, practical draft work exercises, and group stays will be held outdoors in a fenced area with plenty of shade. The freight haul will be held outdoors on meadow terrain, including varying changes in incline and possible unfenced areas. Crates and exercise pens will be allowed at the site other than in areas designated for testing. Pop-up tents or other types of protection from sun or inclement weather are encouraged and may be left set up overnight (at owner's risk) within the private property fencing of the show site.

ENTRY AGREEMENT
